MOMENT OF SILENCE

- Virgil Jones, 85, of Piqua, died at 6:15 a.m. March 10, 2009, at his residence. Virgil taught secondary Special Education at Troy City Schools for five years before retiring in 1971.
- James Fleenor Tilton, 85, of Troy, passed away March 23, 2009, after a brief battle with cancer. James began working for the Troy City Schools in 1986 and retired after 18 years of driving a school bus.
